1. Review and Approval of Meeting Minutes

2. Purchase Orders

Tower Light/Rescue - Huddleston explained what a light tower is and why it is needed for the Rescue vehicle. He received two quotes (halogen and LED lighting). Halogen was \$18,000 versus LED at \$30,000. He explained the three items on the purchase order. He reviewed the current budget and identified a number of line items that we have underspent. His thought was to use the underspent funds to put the new tower light on the rescue. This way, we would not be required to raise any more money next year for this.

Motion:

by Howard, seconded by Brothers, to approve a purchase order to Lakes Region Fire Apparatus for a not-to-exceed total of \$21,783.30 for the light tower to be installed on the Rescue vehicle. **All in favor, motion passed.**

Cab/Tower - Carl West will go by and take a look at the cab. Huddleston received an on-line notice that the company has been sold. He is hoping that when Carl West goes down there, if it is in good condition, he can ask for a check to mail down to them. If there is money left in the Tower 1 budget, he asked that it be carried forward to 2016 for that vehicle.

The 2016 operating budget will be \$397,210 with \$20,000 in capital reserve for operating budget and \$50,000 (until we have a better number) for fire suppression.
