C. Jewell Hill Boiler Replacement – One bid was received from White Mountain Oil & Propane (WMO&P) dated July 16, 2021. Howard read the proposal for all present in person and via conference call. The total bid was for \$10,745 (unit - \$5,395, materials - \$2,850, labor - \$2,500). Discussion ensued specifically around the fact that this proposal was not for the BTUs recommended in the specifications. Shane with WMO&P brought the Viessmann rep up to look at the job and prepare a bid for what he recommended would be necessary. Commissioner Howard thinks we must reach out to WMO&P to understand the difference of the proposed BTU output that they recommend versus Nick Anania's recommendation. A special meeting can be called if necessary. Discussion ensued. Commissioner Castle thinks if the specs are changed and a lower BUT unit is allowed, it should be put back out to bid.
