To hold the vehicle a Purchase Order for a \$500.00 deposit was reviewed and approved. The deposit check was a second payable manifest. The Chevrolet Tahoe's emergency equipment is to be removed prior to being salvaged. The Tahoe is to be towed and not driven to be disposed of.

7. New Business

A. Replacement Tower Apparatus

Chief Huddleston presented that he, Chris Ouellette and Richard Patterson travelled to Sayville, New York to inspect a 1986 aerial tower ladder apparatus that was rebuilt in 2010 that is being readied for removal from service and eventual sale. The piece of apparatus is very nice and expected to be assessed at an elevated value. The apparatus will be sold via sealed bid and likely to be above our budget, but we will forward a bid when the apparatus is sold. Chief Huddleston noted the department's tower apparatus is fully functional, but at some point in the future will need to be replaced.
